I. Call to Order

III. Approval of Minutes of the May 2, 2022, Meeting

IV. Global Market Trends

NMA President & CEO Rich Nolan led a discussion on supply chain and other challenges being faced by the association's manufacturing members including labor shortages, tariffs, rising prices and inflation.

V. MSHA/OSHA Update

Paul Krivokuca provided an update on agency and association safety activities. First, he gave an update on reported on the latest Mine Safety & Health Administration (MSHA) regulatory efforts including the upcoming crystalline silica standard. He also discussed plans to reinvigorate CORESafety, with initial steps to include a review of the existing modules.

VI. U.S. Department of Commerce Information on Quebec Mines + Energie Conference

Katie Sweeney alerted members to the opportunity to participate with a U.S. delegation formed by the Department of Commerce to promote their services in the Quebec mining market at a Nov. 2022 conference. Ms. Sweeney also provided a recap of top NMA regulatory priorities including upcoming rules on silica, waters of the U.S. and National Environmental Policy Act reviews.

VII. Communications Update

Ashley Burke provided an update on the NMA's communication activities and strategy. She discussed the use of NMA's Minerals Make Life and Count on Coal platforms to advance NMA's messaging. She also highlighted the effectiveness of NMA's social media presence which has attracted over 500,000 active followers that regularly share our content from blogs to videos and other postings.

VIII. MINExpo INTERNATIONAL® 2024

Katie Coon provided an update on MINExpo 2024, which is scheduled for Sept. 24-26 at the Las Vegas Convention Center in the West, North, Central and South Halls. She indicated space sales would begin the following month with a new single signon process. She also noted new hotel partnerships for room blocks including Resorts World and Fontainebleau.
